About a year ago R. T. My dear Mr. Sayre:

The Camping Committee of the Finger Lakes Council, Boy Scouts of America, is faced this year with the necessity of making several much needed improvements on Camp Tarion.

A survey conducted last summer by R. W. Morris, Chairman of Health and Safety for this Council indicated the need for correction of several safety hazards including the replacement of a Motor Boat which is used as the only means of transporting supplies and persons to Camp.

As we surveyed our resources, we found that our known income will fall short of coverning the cost of improvements that must be made. As you no doubt know, Camper fees are maintained at a low level to make it possible for the greatest number of Scouts to attend camp. These fees cover operating expenses but do not allow for capital outlay. Such expense is borne by the Council budget, a Trust Fund and outside sources.

It has been suggested by several members of the Geneva Rotary Club that perhaps that Organization would be interested in contributing toward the purchase of necessary camping equipment, and that with the Geneva Club leading, other Rotary Clubs in the area might also participate.

Our knowledge of the interest of you and your Club in Scouting locally has prompted us to lay this matter before you. We shall appreciate your reaction and shall be anxious to have your suggestions.
